

**CALL FOR PAPERS: 20TH ANNUAL C. D. DESHMUKH MEMORIAL
SEMINAR, 2019**

Every year NIA organises Sir C. D. Deshmukh Memorial Seminar with sponsorship of LIC to commemorate the birth anniversary of the first Indian Governor of the Reserve Bank of India and the Finance Minister in Union of India. The seminar attracts practitioners, academicians and experts from life insurance & pension in large number.

On this occasion of 20th Annual C. D. Deshmukh Memorial Seminar, NIA invites authors to submit original research papers in the area of Insurance, Pension and Allied sectors and Risk Management. Papers should bring out new ideas that are executable by the industry in India. The theme of this seminar is “Well-being: Strategic Response from Life insurers, Health Insurers and Pension Providers”

We welcome submission of manuscripts that meet the general criteria of significance and academic excellence on following topics:

1. Individual Well-being : Strategic Response from Life insurers/ Health Insurers / Pension Providers
2. Social Well-being: Strategic Response from Life insurers/ Health Insurers/ Pension Providers
3. National Well-being: Strategic Response from Life insurers/ Health Insurers/ Pension Providers

Authors of shortlisted papers will be invited to present the paper in Sir C. D. Deshmukh Memorial Seminar followed by open house discussion. All papers received will be subject to a peer-review (double blind), followed by moderation. Papers will be considered on the basis of their significance, novelty and usefulness. The review output will be either accepted or rejected. A paper once rejected will not be considered again for review. For accepted paper, should an author be

requested by the editor to revise the text and minor changes, the revised version should be submitted within 15 days.

Best three papers will be awarded with First (INR 25,000/-), Second (INR 20,000/-), and Third prize (INR 15,000/-), in the Seminar. Papers will be published in the proceedings of the seminar and select papers may be published in subsequent issues of 'BimaQuest – The Journal of Insurance, Pension and Management' (ISSN 0974-0791) subject to acceptance parameters of the journal.

NIA will ensure fair treatment of all the academic inputs presented through papers and reserves rights of decision related with award of prizes and publication.

The seminar will be held in the second week of January 2019. The date of seminar will be announced in due course.
