Late Sir C D Deshmukh (1896 – 1982) was an eminent Scholar, educationist and a pioneer in the domain of Insurance & Finance. He was CIE, ICS, an Indian Civil Servant and the first Indian to be appointed as the Governor of Reserve Bank of India in 1943. He was the Finance Minister of India from 1950 to 1956 and had played a stellar role in the integration and amalgamation of 245 companies [i.e. 154 Indian Insurance Companies, 16 Foreign Insurance Companies and 75 Provident Societies] into one **Life Insurance Corporation of India** that came into existence on 1st September, 1956, which is a defining moment in the Indian Insurance history.
