PROGRAMME DURATION AND SCHEDULE

The Course will be conducted from **14th June 2025 to 20th September 2025** in online mode on MS Teams Platform. Fourteen (14) Sessions will be of 3 hours duration and will be held every **Saturday from 10.00 am to 1.30 pm** (with a break of 30 minutes)

PEDAGOGY

Inputs will be delivered in English by industry experts and faculty members of NIA. Depending upon the need, industry experts may use a variety of pedagogical methods that may include lectures, presentations, case study, discussion, assignment and exercises.

EXAMINATION DETAILS

Final Exam for the course will be announced during the programme and would be for a duration of 100 minutes for 100 marks. Candidates need to secure 60% in the Final Exam to be eligible to receive the '**Diploma in Reinsurance**' from NIA. Candidates who fail to obtain 60% marks may re-appear in the examination on payment of Rs **1500+GST**. Accordingly, the dates for the re-exam will be announced later.
