Chair Professor (Life Insurance)

1. National Insurance Academy (NIA) invites applications from existing and retired officers of the Life Insurance Corporation of India for the position of Chair Professor (Life Insurance).
2. **Eligibility:**
 - Existing or Retired Executive Director level officers, not more than 62 years of age as of 1st December 2025.
 - Must have an aptitude for Academics and Research
3. **Pay:** The Chair Professor shall be paid a fixed Basic Pay of Rs.2,05,600/- p.m. plus Dearness allowance and transportation allowance as per 7th Central Pay Commission PB-14.
4. **Other** terms and conditions of appointment, like leave, PF, etc. will be as applicable to Chair Professors at NIA.
5. Unfurnished accommodation on the campus will be provided subject to rules of the Academy
6. The incumbent will be appointed initially for a period of two years on a contractual basis, which can be further extended, after satisfactory review, for a further period of one more year or upto 65 years of age, whichever is earlier.
7. The **responsibilities** of Chair Professor may include the following:
 - Academic & Administrative leadership;
 - Oversight of the Life Insurance faculty and work with faculty to design Management Development Programmes;
 - Lead research and consultancy activities;
 - Conduct & Coordinate MDP sessions;
 - Publish articles and research papers;
 - Maintain relations with insurers, intermediaries and other stakeholders in the insurance sector;
 - Review the PGDM curriculum and teach;
 - Conduct Seminars & Workshops;
 - Conduct Examinations for and on behalf of different organizations;
 - General Administration and committee work;
8. The applications complete in all respects in the prescribed proforma (**Annexure I**) must be emailed to director@niapune.org.in and a signed application, along with the relevant self-attested documents, should be sent by Speed Post / Courier in a closed envelope superscribed “**Application for the post of Chair Professor (Life Insurance)**” to reach the Director, NIA not later than **5.30 p.m. on or before 24th November 2025** at the address given below:
