National Insurance Academy is an Educational Institution established by Government of India (Ministry of Finance, Insurance Division), along with Life Insurance Corporation of India and General Insurance Corporation of India and the four Public Sector Insurance Companies like NIACL, NICL, OICL and UIICL. Its main functions are training of senior level executives, research, and consultancy in insurance management. NIA also provides dual expertise to the PGDM students in Insurance and management. The campus of the Academy is located on a 32-acre plot comprising of Teaching blocks, Library, Administration building, Hostels, Dining hall & Kitchens, Multi-Purpose Hall, Conference Hall, Gymnasium and Swimming pool and residential complex. The campus has a capacity to provide residential accommodation to 170 participants and 240 students at a time who undergo training at the Academy.

NIA proposes constructing a G+1 building with 2 classrooms for its PGDM program. Thus, NIA intends to engage architectural services for planning, designing, estimating, preparation of tender documents, MEP, structural and layout drawings for execution by the contractor, and obtaining the approval of the proposed Classroom Building from Pune Municipal Corporation (PMC). The selected agency will be responsible for liaising with all government authorities and obtaining the commencement and completion certificates for the building.

Qualified and experienced Architects/Engineers/Consultants are invited to apply to the Director, National Insurance Academy, Balewadi, Baner Road, NIA Post Office, Pune 411 045. The last date for receipt of applications in a sealed envelope is on or before 5:30 p.m. on 05.06.2024.

A pre-bid meeting will be held on Thursday, 30.05.2024, at 11:00 a.m. All queries regarding the scope of work, nature of work, etc., will be addressed on that day.

TERMS OF PAYMENT

The area measured is approximate. However, the amount finally quoted by you is fixed and would not change as per the area. The minimum room size for the classroom should not be less than 1300 sq.ft.

The payment shall be released in following steps of work completion,

- 1. 10% of Grand Total: On finalization of plan, elevation, section along with final 3D view of the building approved by the authorities of NIA.
- 2. 20% collection of all the documents required for PMC Building sanction, submitting of project for approval of PMC in all respects and correction of changes suggested by the PMC authorities.

- 3. 30% on obtaining the commencement certificate, structural drawings from licensed structural engineer, electrical and MEP drawings from concerned consultants, estimate of project from licensed estimator along with bar bending schedule and preparation of BOQ for tender of work execution.
- 4. 30% on obtaining final completion certificate from PMC along with final checking of the completed work free from all snags and preparation of as built drawing including furniture layout and ready to use the classroom and allied structures.
- 5. 10% of the total value of the bill along with EMD of Rs.5000.00 will be retained as security deposit and will be released after 3 months from final date of completion of work.
